- Universal and correct wearing of masks:
McComb Local School will follow the Ohio Department of Health and Hancock County Board of Health guidelines.
- Physical Distancing:

- Handwashing and respiratory etiquette:
McComb Local Schools will continue with current handwashing and respiratory etiquette guidelines.

- Appropriate accommodations for children with disabilities with respect to the health and safety policies:

Each district and community school should post on its local website a plan which describes how it will ensure continuity of services including but not limited to:

- Services to address the students' academic needs, and students' and staff social, emotional, mental health and other needs, which may include student health and food services:
McComb Local School's District Leadership Team will review student data and identify both academic needs and SEL needs. The DLT will provide input into how to best support the identified needs throughout the instructional day or by offering services outside of the regular school day. They will also collect data on staff's social, emotional, mental health and other needs for determining how to best support the identified needs of staff.
- The LEA periodically reviews, no less frequently than every six months for the duration of the ARP ESSER grant period (i.e., through September 30, 2023), and revises its plan as appropriate:
